

# What is a Notary?

A notary public is authorized to witness the signing of important documents and administer oaths and affirmations. A notary public may be a lawyer, paralegal, judge, or other authorized official.

#### The primary purpose of a notary public is to prevent fraud by:

- Verifying the identity of a person signing a document
- Ensuring a person swears or affirms they're telling the truth
- Confirming that the person is of sound mind and is signing willingly

In today's digital world, fraud prevention is more important than ever – and fortunately, online notary services are now legal in Canada.

This is after the enactment of new legislation on May 2, 2020 where the Government of Ontario amended the Notaries Act, under Bill 190, which establishes **that a notary public may "exercise his or her powers with or without being in a person's physical presence"**.


